### Park Rules

These park rules are designed to make the stay of you and other park guests as safe and pleasant as possible. Proper compliance with these park rules ensures the safety of you and our guests, we hope for your cooperation and understanding.

- All guests must check in at the front desk upon arrival.
- The rules in these regulations also apply to your visit. After 10:30, your visitors are not allowed to stay in the park.
- Visitors should park their cars in the central parking lot in front of the barriers.
- Guests must check in at the reception desk upon arrival. They must pay the applicable lodging rate.
- You are allowed to park 1 car on your pitch. We activate a maximum of 1 license plate per pitch. Parking on empty pitches and on or along roads is not allowed.
- The barriers are closed between 10:30 pm and 7:30 am.
- The park has a maximum speed limit of 10 km/h for vehicles.
- Our guests are expected to be considerate of other guests in the . In case of recurring nuisance, nuisance guests may be removed from the park without refund of staging fees already paid.
- The park has camera surveillance in several places.
- It is not permitted to use radios, televisions, musical instruments or other noise-producing devices in such a way that they cause a nuisance to other campground guests or nearby residents.
- Between 10:30 p.m. and 7:30 a.m., there is night rest on the . Vehicles are not allowed to drive during that time frame and no sound carriers may be heard outside your camping unit.
- Guests and visitors are not allowed to ride scooters, mopeds and quads around the park.
- Flying drones is not allowed.
- Dogs are welcome, at the applicable rate. However, they must always be (briefly) leashed. Dogs may not be let out on the beach and may only swim in the designated dog pond. Any contamination must be cleaned up immediately, which can be done by means of the cleaning equipment provided by us.

- set depodog bags. Dogs are not allowed in the reception area.
- You are not allowed to demarcate your pitch with a fence of any kind.
- Open fire is prohibited throughout the park. However, fire pits are allowed.
- Barbecuing is permitted provided the following rules are observed:
  - o Use a safe barbecue that is the ground.
  - o When using a coal barbecue, make sure the coals are completely burned out before depositing them in the dumpster. It is not allowed to deposit burned out coals in bushes or fields.
  - o Always keep extinguishing water near your barbecue and fire pit.
  - Never use highly flammable liquids to light a barbecue.
  - o In extreme drought conditions, barbecuing and the use of fire pits will be prohibited
  - by governments and/or management.
- It is not permitted to consume your own refreshments on our terraces and in our catering facilities.
- Consumption of alcoholic beverages is permitted only at the catering establishments and your accommodation.
- Driving vehicles under the influence of alcohol and/or drugs is strictly prohibited throughout the park.
- The use and possession of drugs is not permitted at the park.
- No is allowed around your pitch in the camping areas.
- The use of garbage bags is mandatory. Full garbage bags can be deposited in the designated containers. Garbage, paper and glass are collected separately. You are not allowed to deposit bulky waste on the park; you can deposit this at the waste disposal facility in Wilsum.
- In the event of contamination or damage to the grounds, structures and/or plantings, you will be held liable for the costs.
- It is not allowed to transfer your pitch to others without consulting the reception.
- You must place your camping equipment on the reserved spot.
  Misplaced camping equipment must be placed. If in doubt, please report to reception and we will be happy to help you.
- It is not allowed to connect two or more camping devices with an awning or party tent.
- Use of our (play) facilities is at your own risk.

- Wilsumer Berge is not liable for personal injury, theft, loss, damage or destruction of your property. We strongly advise you not to leave valuables unattended.
- In case of early departure, there will be no refund of camping fees paid.
- In case of non-compliance than these regulations, the management may decide to remove guests from the premises, without refund of paid fees.

\*Wilsumer Berge Resort GmbH has the right to make changes in fees and park rules at all times.

## House rules for you and your dog

Dogs are allowed on our camping site, but there are some rules that you, as a dog owner, must. This is obviously to ensure livability and hygiene on our camping site, but also to protect our neighbors' pastures and crops.

- Exhaustion outside the camping area.
- Keep your dog on a short leash on the way out.
- Clearly carry a poop bag with you or use our Depodog dispenser bags at the waste bins.
- Clean up an accident immediately.
- Bags may be available at our front desk.
- It is advisable not to let your young children walk the dog. You are responsible for your dog yourself!
- Keep your dog on a leash in the campground as well. Not everyone is equally enamored with your pet.
- Dogs are prohibited in the store. This is because this an area where food is prepared.
- Furthermore, dogs are not allowed on our beach and swimming water, at the playgrounds, our rental accommodations and sanitary buildings.

# **Cancellation Policy:**

Of course you are looking forward to your vacation, but unfortunately it may happen that you have to cancel your vacation. Wilsumer Berge works with the following cancellation conditions:

Once you have confirmed your booking with us, by phone, online or our reception, you agree to our Terms and Conditions. In the

General Conditions states, among other things, that we will charge fees after a cancellation, regardless of the reason for cancellation. These charges as the date of arrival approaches, the closer to the date of arrival the cancellation occurs, the less likely we are to still be able to rent your spot in your chosen time frame, in addition other guests have not had the opportunity to reserve the spot.

- Longer than 42 days before arrival 30% of the booking price
- From 42 to 28 days prior to arrival 60% of the booking price
- Less than 28 days before arrival 90 % of the booking price
- Until the day of arrival 100 % of the booking price

We recommend you take out cancellation insurance, these are offered by your insurance advisor, bank or ANWB.
