

General Terms and Conditions

- Fam. Van Stuijvenberg, hereinafter referred to as "the manager", is the owner of Camping De Grienduil, which consists of a campsite, motorhome sites and various rental accommodations (vacation homes, apartments, B&B, Pods, Tiny House and a pipowagen). Located at Geer 25 in Nieuwland, KVK 37134895
- The administrator may be replaced by a third party and/or his family.
- These General Conditions apply to all tenants and residents, hereinafter referred to as "the users", of Camping De Grienduil at the address Geer 25 in Nieuwland.
- Users are obliged to familiarize themselves with these Terms and Conditions and to abide or act in accordance with them.
- By entering into a reservation, these Terms and Conditions become applicable.
- Upon request, a copy of these Terms will be provided to users free of charge.
- For damage to, damage, loss or theft of users' property, the manager is not liable. In case of disputes, all (legal) costs shall be borne by the users.
- All risks related to a stay at Camping De Grienduil are the responsibility of the users.
- Damage and loss of movable and immovable property of manager shall immediately reported and reimbursed to the manager by the users.
- The total amount of the reservation fee must be paid in advance. The manager may or may not deviate from this rule in consultation with the users.
- The administrator's records will be decisive in case of mutual disagreement unless the users can prove otherwise.
- It is not permitted to trade, offer goods, services on the grounds of Camping De Grienduil without written permission from the manager.
- To stay at Camping De Grienduil, at least 1 person of the users must be 18 years of age or older.

Reservation and confirmation

- After receiving the reservation confirmation from the administrator, the reservation is final. However, the administrator can cancel the reservation at any time, administrator will inform users about this as soon as possible.
- Our written reservation confirmations refer to these Terms and Conditions.
- There is no additional charge for making a reservation.

Arrival and departure

- Users must first check in at the front desk upon arrival.
- In case of early departure of the users, they will owe the full price for the agreed period.
- Users must report to the before departure.

Cancellation

- If users are unexpectedly unable to with the reservation agreement entered into, users should notify this as soon as possible.
- Cancellation of reservation up to one month before arrival day; no charge for users.
- Cancellation of the reservation within one month before the arrival day; cost for users: 100% of the agreed total price.

Third party use

- Use by third parties of a camping device and/or associated camping pitch or accommodation is permitted only if the manager has permission. There may be additional costs associated with this.
- Conditions may be to the permission given, user will be informed about this.
- Subletting of pitches and/or accommodations is not permitted.

Maintenance and construction

- The manager is obliged to keep Camping De Grienduil in a good state of repair.
- Users are obliged to keep the camping equipment placed by them and the associated pitch or accommodation in the same state of repair.
- Users, co-users and/or third party(ies) are not allowed to dig on the grounds, cut down trees, trim bushes, fences or partitions, or place structures or other facilities of any kind near, on, under or around a camping means/accommodation without prior permission from the manager.

Separate regulations

In addition to these Terms and Conditions, users must abide by the Regulations Camping De Grienduil.

If users do not comply with these General Terms and Conditions and/or the Camping De Grienduil Regulations and/or show inappropriate behavior, this may be grounds for removal from Camping De Grienduil or denial and/or refusal of access to Camping De Grienduil, without further notice and justification and without refund of the total amount. The police may be called in. If enforcement officials come to Camping De Grienduil and find abuses by users, any fine must be paid by the users themselves and if a fine is imposed on Camping De Grienduil because of abuses by users, this fine will be recovered from users in question.
