You want to rent an accommodation at Bospark de Brenkberg:

ARRIVAL AND DEPARTURE

On the day of arrival you will have access to your rental accommodation from 15:00, Check-in is possible between 15:00 and 21:00 at our reception.

On the day of departure, before 11:00 a.m. the to leave the rental property. The accommodation must left wipe-clean. Dishes are done and put away in the kitchen cupboards. Final cleaning does not include; wash dishes, pick up and collect linens; put trash in trash bag and deposit in container

FIRST DEPARTURE

If you check out earlier than the original departure date, it is not possible to refund you the remaining days. You are responsible if you leave the Forest Park earlier than the original check-out date.

CANCEL

Reservations can be cancelled free of charge up to 48 hours before arrival. If you have already paid the rent (in part), you will receive a Voucher from us with a validity of 1 year.

We accept Corona related cancellations free of charge until 10:00 the day of arrival. Illness during the stay does not lead to a refund and for this you must out your own cancellation insurance.

PAYMENTS

Your reservation confirmation will show your payment terms displayed. Payments must be no later than the arrival date of your stay. BED LINEN AND TOWELS

In each rental accommodation, bed linen and 1 set of towels per guest (1 large and small bath towel) are INCLUDED. Interim change is possible at € 5,= per set. With a minimum of 1 week, you can request a free change at the reception.

PARK REGULATIONS

It is forbidden to cause (noise) nuisance to fellow guests.

From 11 p.m. to 7 a.m., silence must be observed on the premises.

The maximum speed is 10 km per hour. Only parking in the designated spaces or in the parking lot is permitted. Parking on the thoroughfare is prohibited.

Open fire is prohibited. Only limited fire in designated pots or barbecues is permitted. You must have your own sufficient fire extinguishers. In case of drought, limited fires must be discussed with the leadership.

It is not permitted to remove or prune trees and shrubs.

The rules regarding the Corona must be strictly followed. These rules are based on the RIVM and municipal guidelines.

The decision of the Brenkberg leadership are binding, in those cases not covered by these regulations.

De Brenk Berg BV and/or De Brenkberg OG BV and/or De Brenk Berg Holding BV does not accept liability for:

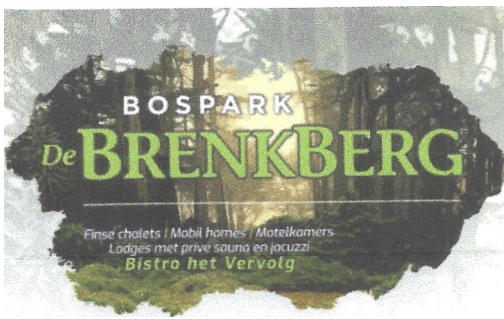
- Theft, loss and/or damage of any kind during or as a result of a stay at Bospark De Brenkberg;
