General conditions

BEFORE YOU BOOK THIS

Have you chosen Costa Kabrita as your vacation destination? Please go this important information first. Then you can be sure that you are aware of everything when you make your reservation!

CONDITIONS

All conditions apply to all bookings, made directly or indirectly with Costa Kabrita. The prices, dates and times on www.costakabrita.nl have been prepared as accurately as possible, but are however not binding. Costa Kabrita reserves the right to make changes. Upon booking you will be notified of the final price. Price changes are reserved.

Costa Kabrita is for recreational only, so no permanent residence.

FINANCIAL

- If, after setting the agreed price, because of an increase of the burden on the of Costa Kabrita, additional costs arise as a result of charges and/or levies (for example VAT, tourist tax, etc.), which are directly related to the vacation accommodation or the holiday maker, Costa Kabrita may pass these on to the holiday maker/booker, also after the conclusion of the agreement and/or making the booking.
- Children up to 1 year old are free.
- Apartments, Mobile home, Wine barrels, Finnish Kota's, Dome, safari tents and tunnel tents prices include water, electricity (with normal use), VAT, bed linen. Cleaning costs are automatically added € 25.00 per stay. Tree-Lodges same as above, only without bed linen.
- Camping person prices include VAT.
- Any discounts and/or special offers can no longer used if the confirmation/invoice has already been sent by Costa Kabrita.

RESERVATION AND PAYMENT REGULATIONS

- After booking, will receive a reservation agreement with payment instructions and automatically agree to our terms and conditions.
- Reservations of the rental locations (Apartments, Mobile Home, Wine Barrels, Finnish Kota's, Dome, train lodges, safari tents and tunnel tents) must be paid immediately at the time of booking, Only after payment is the booking final.

- Seasonal pitches and longer term bookings (such as pre-post season),€ 50.00 advance
 payment must be made at the time of booking. After that, the installments are listed on
 the contract.
- Every single camper paid everything a day before departure.
- When booking online, it is possible to pay directly via IDeal.
- If the holiday maker leaves early, the full price of agreed upon rate period shall still be due
- If Agreements expire automatically after the expiration of the agreed period.
- Costa Kabrita shall at all times be entitled to terminate the reservation agreement with immediate effect if, when making a reservation, personal data of you and/or other users are incomplete and/or incorrectly provided.
- The entrepreneur, the tenant and other users are not allowed to give the rental locations (Apartments, Mobile Homes, Wine Barrels, Finnish Kota's, Dome, train lodges, safari tents and tunnel tents) or camping site, for use to anyone other than the persons named in the agreement, unless otherwise agreed in writing with Costa Kabrita.

CANCELLATION POLICY

We recommend that you use cancellation insurance.

- For cancellation more than 3 months before the start date, 15% of the price;
- For cancellation within 3 to 2 months before the start date, 50% of the price;
- For cancellation within 2 to 1 month before the start date, 75% of the price;
- For cancellation within 1 month before the start date, 90% of the price;
- For cancellation. on the day of the start date, 100% of the agreed price.

The remuneration shall be refunded proportionally, after deduction of administration costs (5% of price, with minimum of \in 27,50 and maximum of \in 55,00, if the place is by a third party on the recommendation of the holiday maker and with the consent of Costa Kabrita, for the same period or part thereof.

CONDUCT RULES

- Recreant, his family members, lodgers, visitors and other users shall comply with the
 regulations. If the set rules of conduct and/or agreement are not observed, despite warning,
 Costa Kabrita has the right to cancel the agreement immediately. The holiday maker must
 clean up, remove and leave Costa Kabrita soon. In very urgent cases a warning can be
 omitted.
- If the holiday maker fails to vacate his place, Costa Kabrita shall be entitled to do so at the expense of the holiday maker.

DEPARTURE RENTAL LOCATIONS:

• Please leave the location in good condition.

• By "good condition" is meant, among other things, that before departure the bed linen has been removed, the kitchen inventory (including microwave, electric pan, coffee maker, etc.) is clean, also in the common room (stove/ oven or what you have used) left clean and the garbage has been taken to designated container.

CAMPING PLACE:

- Please leave the place in good condition.
- 'Good condition' includes leaving the site tidy before departure, no more pegs left in the ground.
- Leave the common area (stove/oven or what you used) clean after use.
- Household garbage to designated container. Taking bulky waste home

If holiday maker to, the collection agency will be engaged, if the amount is not paid on time, then during collection an interest rate will be calculated on the amount still to be paid.

If you rent our apartment or mobile home for an extended period of time, you have no right to live (so are no residential rights at all), and the rental always remains recreational, so if there is a dispute Costa Kabrita always has the right to evict you and rent you out again to others

All disputes relating to Camping are by Dutch law. Only a Dutch court is competent to take cognizance of these disputes.
