

## TERMS AND CONDITIONS

When making a reservation for a camping pitch or haystack at Camping New Romalo, you agree to the following:

### Cancellation

Camping Nieuw Romalo will in full for cancellations within one month's notice. You must provide your own cancellation insurance.

### Arrival and departure

#### *Times camping:*

Arrival between 11 a.m. and noon or after 1:30 p.m.

Departure before 11 a.m.

Arriving on Sunday is no problem, but you should arrive at 11.00 am. If it is later, please let us know well in advance because of our day off.

#### *Times haystack:*

Arrival from 4 p.m. and departure before 10 a.m.

### Earlier departure

What is reserved is also charged.

### Preferred

Camping Nieuw Romalo does its best to your preferences, but cannot guarantee this. So you may end up on a different pitch than the one you have indicated.

### Other points

Awnings only allowed without sides in them.

If one away from the campsite for more than 3 nights, with the awning must be removed.

You do not have an awning, but only an awning? Then sides are allowed.

Sleeping compartments are only allowed when they are actually used as sleeping compartments. So not as storage or living quarters.

All dogs, large and small will be outside the campground. No cars on the .

Only during arrival and departure.

#### Recipients of personal data
